BRIEF EXPLANATION: The Musée du quai Branly - Jacques Chirac is governmental museum of France somewhat analogous to United States Smithsonian. They are under the Ministry of Culture, Communication and the Ministry of Higher Education and Research. Their national museum is focused on indigenous objects which France acquired from Africa, Asia, Oceania, and the Americas.

They have reached out to Quapaw Nation to invite us to engage in Government to Government consultation, to discuss their collection in detail, including objects from the Arkansas, Louisiana, and Illinois Territory. They have a very large collection of objects from the Arkansas Territory which are from the 1600s and 1700s. Of particular interest to the Quapaw, this includes the Buffalo Dancers Robe, Three Villages Robes, and historic French maps of our ancestral territory; some of which are digitized and some of which are not. Additionally there are numerous objects which we have not had the privilege of seeing before.

Part of this consultation will involve review of information they have recorded, a deep dive into the history of these objects, an effort to incorporate tribal names for themselves in their exhibits (rather than colonial terms), and a discussion of potential future exhibit(s) in the United States.

We have been told they would like to host a consultation the first week in April. A secondary meeting will also be held in November. Apparently, Choctaw Nation is interested in hosting an exhibit of some of these objects, and there is interest in a collaborative exhibit at the FAM museum in OKC, pending further discussion with tribal partners.

After initial discussion, it seems like a team to represent Quapaw Nation in this consultation would be beneficial to Quapaw interests. This team should likely include Carrie Wilson, Joseph Byrd, Billy Proctor, and myself.
